

About Recycle Colorado

Vision

To transform Colorado into a national leader in waste reduction, recovery and diversion.

Mission

To advance infrastructure, end markets, and state and local policies in waste reduction, recovery and diversion.

Recycle Colorado is the leading independent, non-profit organization in Colorado that is actively working to advance infrastructure, end markets and state and local policies so that Colorado's waste stream is recycled, composted or diverted to reuse or remanufacturing.

Standard Membership Benefits

There are multiple benefits to joining Recycle Colorado and supporting the organization's vision and mission. Year-round, through councils and webinars, members keep up to date on the latest trends in recycling and materials management, form new professional relationships, make sure their voice is heard and participate in numerous fun events.

Membership Directory

Programs, Events and Work Groups

Attending Recycle Colorado events and participating in a council or committee are the best ways to utilize the benefits that Recycle Colorado has to offer. Recycle Colorado represents you and, to ensure that your voice is heard, you need to stay involved.

Recycle Colorado Councils

Members have the option of joining one of Recycle Colorado's councils. Councils hold quarterly meetings where members collaborate and share industry developments. Regional councils focus on a specific geographic area in Colorado while subject-matter councils bring together people interested in specific focus areas of waste reduction, diversion and recovery across the state or in certain industries or sectors.

Composting Council

The Composting Council promotes sustainable utilization of organic resources in communities around the state. The council works to increase composting infrastructure, create and drive end markets requiring standards for use and drive state and local policies requiring the use of organics recovery and compost use. Recycle Colorado's Composting Council is a state chapter of the United States Composting Council.

Construction and Demolition Council

The goal of the council is to bring together all of the businesses, organizations and government units that impact or have input on a closed-loop system for C&D material.

Northern Colorado Council

This council serves Larimer and Weld counties and surrounding areas.

Western Slope Council

The Western Slope Council serves multiple counties including Mesa, Delta, Montrose, San Miguel, Ouray, Pitkin and Gunnison.

Policy Committee

The Policy Committee fills multiple roles for Recycle Colorado. The committee tracks and promotes items of importance to the recycling community, educates legislators and decision makers, and works with other organizations to ensure that the voice of recycling is heard in Colorado. The committee makes recommendations to the Recycle Colorado board of directors regarding involvement in political issues, hosts stakeholder meetings on current policy issues, and periodically hosts events at the Capitol. The Policy Committee meets every month and also holds a one-day policy retreat each year.

Summit for Recycling

The annual Summit for Recycling conference brings together members, industry and business representatives, stakeholders and anyone interested in recycling in Colorado. The Summit agenda includes a Business Partner Showcase, breakout sessions, plenaries, awards, tours, silent auction and more.

Annual Meeting

The Annual Meeting happens each year in the fall and is a networking meeting for Recycle Colorado members and people interested in becoming members. The event highlights what's going on in recycling around the state and the recent activities and accomplishments of Recycle Colorado.

Publications

Quarterly Newsletter – The electronic newsletter provides the latest information on Recycle Colorado programs and activities and highlights member accomplishments. Article submissions are open to all Recycle Colorado members who want to share news about events, research, legislation or other information relevant to recycling professionals in the state.

Bi-weekly Updates – We combine various announcements and news items into one convenient e-mail every two weeks, including news from members, training and meeting announcements and other noteworthy items that cross our desk.

Website

Our online platform provides a Job Board, where you can share your company's job opportunities. Members can send submissions to info@recyclecolorado.org for posting. The Events Calendar outlines upcoming Recycle Colorado and other industry event information. And we're always reaching out to media outlets and other communication networks to share the work of our members and organization that we highlight on our News Feed.

ReCircle is an online knowledge hub and communications tool allowing individuals, businesses and organizations to connect for the purpose of advancing material circular economies through reuse, remanufacturing and recycling.

2020 Recycle Colorado Annual Report

Recycle Colorado has promoted recycling in the state since 1991. We are an action-oriented organization that works on tangible, actionable and measurable projects and events related to infrastructure and end markets for material recovery, reuse and manufacturing. Our vision and mission come to life through councils, events, round tables, webinars and policy. We expanded our membership in 2020 by offering any number of individuals in a partner organization to participate. We completed a significant project that expanded the scope of our capabilities with the assistance of our partner organizations. Our Policy Committee, with its 15 sector representatives, worked with stakeholders to provide a voice for recycling during the state’s stakeholder process for end-market development – established by SB20-055.

In April, Recycle Colorado hired a new executive director, Kristin Kim, who lead the organization through the challenges and opportunities associated with a global pandemic. While many of Recycle Colorado’s activities were already conducted virtually, the annual Summit for Recycling conference was successfully pivoted to a virtual format, along with the Annual Meeting and a new, additional networking event. Recycle Colorado will continue to take advantage of the inclusivity and equity provided by a virtual environment and also looks forward to again hosting in-person events that provide that extra level of connection for members.

Operations

Recycle Colorado employs one full-time executive director and one part-time associate executive director. In 2020, Recycle Colorado contracted with an accountant and lobbyist.

Membership

Recycle Colorado’s membership decreased 14 percent to 331 in 2020 from 386 in 2019. Dues income Decreased 22 percent from 2019.

Recycle Colorado continues to focus on adding value for its members, evidenced by the following activities in 2020:

Events

Summit for Recycling

The 2020 Summit for Recycling two-day virtual event featured plenaries and break-out sessions and networking opportunities for waste diversion and recycling professionals from the business, government, not-for-profit and university sectors. The 2020 theme was “Building a Circular Economy in the Rockies.” The Summit:

- Connected 167 attendees, including 10 business partners, 18 sponsoring businesses and Recycle Colorado board members and staff. Attendance levels decreased 27 percent compared to 2019.
- Presented two keynote sessions: "Circular Economies for Resiliency and Efficiency" with panelists from Ball Corporation, City of Boulder, Direct Polymers, Momentum Recycling, Colorado Office of Economic Development and International Trade, and Arizona State University and "Extended Producer Responsibility" with Resa Dimino, Resource Recycling Systems, Inc.
- Coordinated 8 break-out sessions and four Meet & Greets.

- Hosted a Business Partner Showcase panel and virtual recycling tour.
- Presented recycling awards to 12 recipients for their work in recycling.
- Generated \$29,800 in net revenue for Recycle Colorado.

Recycle Colorado thanks our 2020 Summit sponsors. Their enduring financial support allows the Summit for Recycling to continue to be the premier waste diversion conference (in-person or virtually) of the Rocky Mountain region. Recycle Colorado also recognizes the contributions of our volunteers, who provided invaluable programmatic and technical assistance and helped ensure the Summit was a success.

Annual Meeting

The 2020 Annual Meeting was held virtually October 21. Ninety-four recycling professionals registered for the event, only four less than attended the 2019 in-person event. The program included a report on the state of Recycle Colorado and an introduction to the Board of Directors candidates along with updates on the activities of Recycle Colorado's regional and subject-matter councils.

Policy

In 2020 and 2021, Recycle Colorado's Policy Committee:

- Passed SB20-055, Incentivize the Development of Recycling End Markets, to shape the structure and governing guidance of a Recycling End Market Development Center, conduct a study on Extended Producer Responsibility policies and recommendations, and conduct a statewide education campaign on recycling. Recycle Colorado and its members participated in stakeholder work to shape the End Market Development Center guidelines and conduct the Extended Producer Responsibility study.
- Worked with the Department of Agriculture and Department of Public Health and the Environment to develop an organic waste management plan.
- Organized two policy sessions at the 2020 virtual Summit for Recycling, one on local diversion policies and the other on rural diversion policies, and held a meet and greet with key legislators.
- Met with newly elected legislators to introduce Recycle Colorado and our legislative priorities.
- Joined Governor Polis for the signing of the proclamation declaring every third week in November, Colorado Recycles Week.
- Approved 2021-2022 legislative priorities for Recycle Colorado that include: (1) prioritizing the development of new end markets for finished compost; (2) increasing the opportunity for customers to repair, reuse and extend the life of products; (3) working towards a comprehensive Extended Producer Responsibility program; (4) reducing disposable plastic waste; (5) enabling CDPHE to enforce waste diversion goals and implement waste diversion plans; (6) increasing the diversion of valuable materials from the landfill.

Councils

Regional councils focus on a specific region in Colorado while subject-matter councils bring together people interested in specific focus areas of waste reduction, diversion and recovery across the state or in certain industries or sectors.

Northern Colorado Council

At the start of the year, the council was working on a project to encourage businesses to recycle that included "opportunity cards," presentations/trainings, guidelines and recognition opportunities to support business recycling endeavors. The implementation of stay-at-home orders due to the pandemic put a halt to the outreach project. Instead the council utilized its Facebook page to spotlight Recycle Colorado businesses. The council remained engaged the rest of the year by meeting quarterly to share updates from members about how they were adjusting to the new industry environment.

Western Slope Council

The Western Slope Council began the year focused on a public awareness campaign to inform the public about the importance of recycling and composting. A component of the project was the creation of a centralized database (waste app) for the Western Slope that provides information on which materials can be recycled or composted and where to take them. The council met quarterly throughout the year to share news about the coronavirus pandemic and its impact on recycling and composting and also hosted two spotlight speakers: Momentum Recycling and Grand Valley Zero Waste.

Composting Council

The Colorado Compost Council (COCC) is an official state chapter of the U.S. Composting Council (USCC), the national voice of the composting industry. Membership in Recycle Colorado includes access to COCC meetings and updates on industry initiatives. In 2020, the council:

- Held four quarterly business meetings that were well attended.
- Represented Colorado composters at the USCC Annual Summit in Charleston, South Carolina, in January 2020.
- Established an action plan to utilize the Washington's Compost Contamination Toolkit as a replicable model that could be adapted for Colorado.
- Supported the Colorado State Legislature's Organics Management Plan bill, which died in the wake of COVID-19. It was instead adopted by the Colorado Department of Public Health and Environment as a department initiative that will be implemented in 2021.
- Actively promoted the USCC certification program for compost – the Seal of Testing Assurance (STA) Program.

- Worked extensively with the Colorado Department of Transportation (CDOT) to revise compost specifications in roadside projects, which were published in 2020.
- Participated in the Colorado Collaborative for Healthy Soils, a statewide effort to build a broad coalition among agricultural organizations, nonprofits working in the agricultural sector, and state government to draft and present HB21-1181, which will be beneficial to stimulate compost use in agriculture. The bill passed in 2021, and COCC involvement has been essential to ensuring that demonstration projects and policy recommendations generated from the initiative include the use of compost as a practice that promotes soil health.
- Organized two compost related sessions at the 2020 Summit for Recycling virtual conference.
- Obtained approval to sponsor and host a modified virtual Compost Operators Training Course (COTC) in March 2021.

Construction and Demolition (C&D) Council

The Construction & Demolition Council began the research and planning phase to develop a tool that businesses and local governments could use to help them compare different C&D waste-tracking platforms. Working groups created surveys and hosted presentations with waste-tracking tool developers and providers. After completing the research phase, it was determined that the project did not need to be built out any further based on the current industry feedback and market demands. The rest of the year's work and focus turned towards membership, deconstruction and industry outreach, engagement and growth within Recycle Colorado and beyond. Spotlight speakers included AMP Robotics, Building Product Ecosystems, and Perks Deconstruction. The C&D Council welcomed the new 2021 leadership lineup: Michael Port, Chair; Dan Pearsall, Vice Chair; Nina Waysdorf, Recorder; Emily Wilson, Board Liaison; Kristin Klm, Staff Lead.

Projects

Multifamily Recycling Pilot

With Denver's waste diversion goal of 50 percent by 2030 (currently at 23% in 2019), the goal of this project was to understand how much recycling could be captured at multi-family complexes if single-stream recycling is installed. The pilot ran from November 2019 to May 2020 and provided six months of free recycling services to eight selected apartment complexes that did not already have recycling. Overall, the eight properties (representing 152 rental units) collected 239 yards of recyclable materials (the equivalent of 112 pick-up truck loads). All properties are continuing with their recycling collection programs. One property reduced its trash collection service from two pick-ups per week to one as a result of the increase in recycling.

School of Mines

Recycle Colorado worked with ten students from the Colorado School of Mines on the problem of separating plastic labels from aluminum cans. These plastic coverings (while great for branding) cause sorting difficulties at our recycling centers and damage equipment at the aluminum mills. Recycle Colorado coached these students on the overall problem and shared a variety of perspectives from stakeholders who participated in previous Recycle Colorado round-table discussions. Each team analyzed the information and hypothesized three potential solutions and designed a prototype that will be used for preliminary testing.

Recycling Education Campaign

Recycle Colorado reached over 5.2 million residents in three communities between August 2020 and January 2021 with a recycling ad campaign highlighting the importance and benefits of recycling. A total of 8,435 tons of curbside recycling was collected from the three communities during that same timeframe, helping them maintain consistent recycling rates during a turbulent period when the global pandemic increased overall waste collection by 25-30%.

Community Engagement

Recycle Colorado works to build relationships among members and with other organizations and communities throughout the state. Key efforts included:

Material Matters Webinars

On October 26, 24 people registered for "Rural Recycling Resources Webinar" with the RREO Program Administrator for the CDPHE, who gave an overview of the RREO grant program and specifically the recycling rebates available to help service free, public drop-off locations.

On November 24, 83 people registered for "Composting Webinar," an interactive sharing discussion about the many options for offering composting in your community. Panelists from Boulder County, Pitkin County, 3XM Grinding and Compost and Wompost talked about the facts and myths associated with starting or maintaining a composting program and new developments in the Colorado compost scene.

On December 9, 121 people registered for the webinar "You Don't Know Foam (aka Styrofoam)" with Foam Cycle, which offers a recycling system as an efficient way to immediately begin collecting, densifying and re-purposing foam packaging waste at a municipal drop-off site.

Poster Contest

Recycle Colorado received entries from more than 20 schools in 2020, an increase of 122% in school participation from 2019. The winning artwork was showcased on Recycle Colorado's website and Facebook page to draw attention to what can be recycled in Colorado.

Website – In 2020 the Recycle Colorado website, www.recyclecolorado.org, was visited 23,949 times, an increase of 20 percent from 2019, and was visited by 16,000 unique users. Eighty-five percent of visitors were new to the site and the average visit duration was almost two minutes.

Colorado Gives Day - Recycle Colorado participated in Colorado Gives Day, December 5, joining more than 2,500 other Colorado non-profits. Colorado Gives Day is a statewide celebration to increase online giving, presented by Community First Foundation and FirstBank. A total of \$2,390 was donated to Recycle Colorado on this one day.

Communication - Recycle Colorado produced and distributed four quarterly electronic newsletters and 26 bi-weekly updates and shared information on social media channels.

Member Promotion - Recycle Colorado highlighted member successes throughout the year in our newsletters, bi-weekly updates, at the Summit for Recycling, Annual Meeting, and special webinars.

ReCircle

The online platform ReCircle (recirclecolorado.com/) was launched in 2019 as a platform designed to help facilitate the diversion, recovery, and repurposing of the \$265M worth of recyclable materials thrown in Colorado's landfills each year. Users of materials are matched with producers to encourage a circular lifecycle for reusable and recyclable materials.

Financial Health

Recycle Colorado's financial health remained secure in 2020. The organization saw a net revenue of \$10,454. The value proposition engaged members and also produced measurable results that aligned with the organization's goals. We are proud to announce that Recycle Colorado successfully pivoted to an all-virtual format, completed a major grant project that promoted recycling and a circular economy in the state of Colorado and was financially profitable in 2020. By the end of the year, Recycle Colorado showed \$292,771 in total revenue and \$282,842 in total expenses.

Ending the year with a \$15K surplus and continuing operations throughout the coronavirus pandemic was achieved largely because of the dedication from membership and filling the open executive director position. Upon confirming the current executive director, Kristin Kim, the organization rapidly pivoted to conducting business virtually. The Coca-Cola Foundation messaging grant was reworked to account for behavioral changes arising from state, local and personal responses to the pandemic, and the project was completed in the first quarter of 2021. The 2020 Summit for Recycling: Building a Circular Economy, for the first time, became a completely virtual conference and shone with camaraderie and perseverance that we can all be proud of. Other key components to remaining financially healthy were the ability to maintain similar membership levels and keep operational expenses well under budget.




Figure 1. Recycle Colorado Revenue 2020 – All Programs Combined




Figure 2. Recycle Colorado Expenditures 2020
